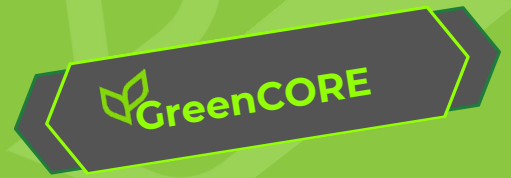

Our GreenCORE checklist consists of **only 13 required measures** (see page 2). Businesses enrolled in this pathway may also qualify for our energy rebates.

GreenCORE Program



Businesses who enroll in our GreenCORE Program must complete a **minimum of 13 CORE measures** (see below). If this checklist feels like a good starting place for your business, we encourage you to sign up as soon as possible so you can apply for our 2026 energy rebates!

Your Green Business Advisor will help guide you through the process and provide any resources, templates, or GreenBizTracker assistance you need to reach the finish line.

- ☐ **Have an environmental policy**
The policy must address the following sections: waste reduction, toxins elimination, environmentally preferable purchasing, water/energy conservation, and education of employees. **Templates available.**
- ☐ **Post signage encouraging resource conservation**
May include: recycling signage and reminders to turn off lights, faucets, and equipment.
- ☐ **Adopt 1 Awareness & Maintenance Energy measure**
Options include: regular HVAC maintenance, training staff to turn off power strips, putting computers into sleep mode after 15 minutes, insulating hot water pipes and cold suction lines, reducing hot water heater temperature, etc.
- ☐ **Adopt 1 Lighting & Equipment Energy measure**
Options include: LED lighting upgrades, smart power strips, LED exit signs, smart thermostat, lighting controls, ENERGY STAR appliances, electric heat pumps, etc.
- ☐ **Use non-toxic cleaning & building maintenance products in non-aerosol containers**
Acceptable certifications include: EPA Safer Choice, Green Seal, EcoLogo, Environmental Working Group Verified (or a 1 or 2 rating), or SF Approved.
- ☐ **Properly store and dispose of "universal waste" as required by law**
Designate a storage area with a sign and notify all employees of the area. UW includes: spent fluorescent bulbs/tubes, aerosol cans, electronic equipment (computers, cell phones, etc.) and batteries.
- ☐ **Recycle cardboard, paper, glass, and cans**
Label recycling bins and educate staff on recycling do's and don'ts.
- ☐ **Adopt 1 Purchasing & Reuse measure**
Options include: using environmentally preferable food packaging, purchasing paper products with recycled content, selecting products shipped with less packaging, etc.
- ☐ **Adopt 2 Waste Reduction measures**
Eliminate Styrofoam within 1 year AND: reduce paper use, print double-sided, eliminate single-use water bottles for staff, or use reusable dishware in the breakroom.
- ☐ **Keep dumpsters and pollutants covered and impermeable to rainwater**
If no covers are available, provide overhead storage. Keep outdoor areas clean and report leaking dumpsters to your waste hauler.
- ☐ **Adopt 1 Indoor Water Efficiency measure**
Includes: low-flow plumbing fixtures, ENERGY STAR certified clothes washers, etc.
- ☐ **Adopt 1 Outdoor Water Efficiency measure**
Includes: WaterSense labeled sprinkler heads, converting to drought-tolerant landscaping, drip irrigation, etc.
